Blood Drive Upcoming



American Bar Association Regional Tournament

The first Tournament to be held this Spring was Association Regional American Bar the Tournament which was held in Jacksonville. Florida from February 13-16. Because of the difficulty posed by the close proximity of the ABA Tournament with the February Bar Exam, GSU was the only law school in Georgia to send teams to Jacksonville. The team composed of Randy Rich, Cheryl Champion, and Charles Jones was undefeated going into the final day of the Tournament, but was narrowly defeated by Cumberland Law School in the final round. The Rich/Champion/Jones team had defeated another Cumberland team in the Semi -Round Additionally, (4-1).Rich/Champion/Jones team had scored victories over Nova (3-0), Florida (2-1), and Miami (2-0).

The team of Steve Ellis, Rhonda Brodsky, and Monte Davis was only defeated in the Tournament by teams from Alabama and Stetson who both competed in the final round. The success of both teams is even more impressive because the GSU Teams were the only teams in the Tournament which included two second year attorneys per team. The teams success were also due in part to the following outstanding second year witnesses which also competed with the teams: Brenda Bates, Clara Bucci, Chandra Carter, and Kim Stephens.

Association of Trial Lawyers of America <u>Tournament</u>

The Association of Trial Lawyers of America Regional Competition will be held in Norfolk, Virginia on March 6-8. Touch the Earth

Many of us have a place where we've stored away objects from childhood that once held great power; pennies crushed on railroad tracks, sling-shots, Barbie dolls or GI Joes. Such relics represent the time we could only wonder what life held in store, and while we played with them we acted out our fantasies and ambitions. To look at these objects and touch them again can return us to the state of wonder and rekindle our visions of life to come.

Being pulled into the past is a powerful experience, making us question our current path, but there are other ways to open the doors of perception within ourselves and begin to see reality and possibility though a different lens. Georgia State's "Touch the Earth" is one such program and operates on the premise that by interacting with the Earth, with the reality of nature, we can more clearly understand the full scope of our individual lives and our collective life.

The trips range from adrenalin producing probes into unknown worlds (caves, swamps, mountains, rivers and oceans) to finding your own private Walden in silent, challenging effort or in calm, reflective repose. Opportunities range from the hedonistic (skiing), to the contemplative (horseback riding), and accommodate enthusiasts as well as the just curious.

For those of us whose childhood ambitions have led to the often difficult and seemingly overwhelming task of law school, a return to the state of wonder can operate like a turn on the tracking knob, clearing distortion from our vision of life to come. A bit of reflection, a bit of challenge on some other grounds than coursework can pull from us, not objects of our past, but pieces of ourselves long forgotten; it could be some of the best invested time of the semester. The touch of the Earth on you may be surprising.

The Touch the Earth program is detailed each quarter in <u>The Recreation Rap-Up</u>, available at the second floor equipment issue desk of the Physical Education building just across the street from the Law School.
