- (a) the sum of One Million Four Hundred and Thirty Eight Thousand Two
 Hundred and Thirty One Dollars and Ninety One Cents in principal and
 interest (\$1,438,231.91);
- (b) attorneys' fees pursuant to O.C.G.A. § 13-1-11(a)(2) in the amount of One Hundred and Forty Three Thousand Eight Hundred and Ninety Eight Dollars and Nineteen Cents (\$143,848.19); and
- (c) Post-judgment interest on such amounts pursuant to O.C.G.A. § 7-4-12;
