### **Exam Schedules**

The faculty recently reconsidered the so-called 24hour rule, and voted to approve it and implement it as soon as practicable. Basically, under the new rule, if a student has two exams scheduled to begin within 24 hours of each other, then a conflict exists and relief is appropriate. For example, if a student is scheduled to take an exam on consecutive days at 6:00 p.m. and 1:00 p.m. the next afternoon, then this schedule would constitute a conflict entitling the student to relief in the form of rescheduling of one of the exams. On the other hand, two exams scheduled to begin at the same time on two consecutive days (i.e., exams on two consecutive days at 1:00 p.m. or two consecutive days at 6:00 p.m.) would not constitute a conflict entitling the student to relief.

As noted earlier, the faculty voted that this new policy should be instituted "as soon as practicable." Because implementation of this new rule for this semester would have created 92 additional conflicts in the exam schedule released earlier this semester, we are in the process of devising a new exam schedule designed to minimize the number of conflicts under the new rules. It is possible that we will schedule exams at three times during each exam day (9:00 a.m., 1:00 p.m. and 6:00 p.m.). We are making every effort to develop the new exam schedule as expeditiously as possible.

### Notes from the Assistant Dean

Bar Exam Information: Larry Thompson, examiner with the Office of Bar Admissions, and Bucky Askew, Director of Bar Admissions, will be at the College on Monday, November 4, at 5:00 in Room 100. Mr. Thompson has sent a question he wrote for the July, 1991 exam, which he will discuss at the Monday evening meeting. He will provide information on what he was specifically looking for in an answer, to help students better understand how to write for the Bar Exam. Students interested in sitting for the Bar in February will want to review this question prior to the 4th so that the discussion will be of more value to you. A copy of this question may be obtained at the 3rd floor reception desk.

Surviving With Stress: Second session, November 25 at 5:00, Room 325-B, continues to prepare you for the coming Exams.

Phi Delta Phi/Red Cross Blood Drive: Yes, we checked; the Red Cross will take blood from lawyers. They will be in the first floor student lounge area on November 21, the Thursday before Thanksgiving, from 12:30 until 6:00.

Exam Numbers: Be sure and pick up your exam number from the receptionist on the 3rd floor. You will need your school ID and fee card.

## **Law Library Computer Lab News**

The Computer Lab now contains a workstation devoted to printing and disk conversion. It is on the left as you enter the Lab and has a slightly different menu from the rest of the PCs. The menu options include several DOS functions, such as copying, renaming, and deleting files. The computer has both 5-1/4 and 3-1/2 inch disk drives.

The Computer also allows you to format your 5-1/4 inch diskette for use in the Lab. The Lab PCs require double-density formatting. Please do not use disks formatted at high density in the Lab.

As some students have discovered, the eleven computers in the Lab have only 5-1/4 inch disk drives. Those students who use 3-1/2 inch diskettes can use this new workstation to copy files to a 5-1/4 inch disk for use in the Lab. Students must supply their own diskettes.

Because this is the only computer in the Lab which has this capability it is reserved for this purpose and for quick printing jobs. WordPerfect 5.1 can be accessed for printing documents. The CALI exercises are also available on this workstation and should be used only to make copies of the exercises.

### **SBA News**

Highlights of the 10/14 Meeting

New Members Sworn In: The newly elected 1st Year SBA Senators, Jill Folino, Tony del Campo and Pam Sullivan were sworn into their offices.

Coffee Preparation: The Board unanimously rejected the proposal to utilize an outside service because it would cost the SBA \$40 per day. The Board also rejected a proposal to compensate Board members who make coffee.

Ranking System: Recent SBA inquiries into the feasibility of changes in Student Ranking Policies have been placed on the faculty agenda through Dean St. Germain's office.

SBA's Stolen Money Problems: Proposals to prevent theft SBA coffee money included ticket sales; placing a slot in the door of the SBA office; sign-up sheets. In the interim, officers were asked to remove-money from the box each day during their office hours.

**Budget Committee:** Will meet to discuss proposed amendments to those provisions in the SBA Constitution which govern the budgetary process. At the present time, approximately \$1800 remains unallocated.

Library Committee: The faculty Library Committee has voted to impose a computer use charge on all students, regardless of use. SBA representative Linley Jones has voiced strong student opposition to this proposal. The SBA will inform students of the next Library Committee meeting so that interested students can attend. Motion to voice the SBA's total opposition to the faculty proposal was unanimously passed after discussion.

Notice Posting Policies: Posting of notices in non-bulletin board areas of the Law School is against the current Law School policy, but the policy remains unenforced by the administration. Motion to recommend to the administration that this policy be removed from the books passed.

**Pre-Law Club:** A proposal that the SBA sponsor a formal and ongoing relationship between the Law School and the GSU Pre-Law passed.

Placement Concerns: A proposal that the SBA sponsor a series of lectures or seminars on alternatives to "big firm" law practice was tabled for the next meeting.

Bar Examination Preparation Courses: Several students have asked that the SBA assist in resolving conflicts involving various Bar Preparation Courses. After discussion, the SBA rejected any involvement in the problem on grounds that this is a completely private matter.

### **Student Comments**

Dear Editor:

Somebody boosted my book from the library and I thought, WHAT A GOOD IDEA. Mercer students don't steal books. Notre Dame students don't even covet each other's pens. Here, ethics applies to assignments for R.W.A. (Really Work Alone) but the miranda notices of High Theft Areas in the Law Library communicate a different message. Are those notices a warning, or the rule to be followed?

The message is not clear. The College of Law here is the new kid on the ABA block. newer than Mercer and Notre Dame, and gets greatness in part by its Atlanta connection, the city of friends, too busy to hate. It's reputation for ethics should be in keeping with its environment. Its ethical message is not clear.

Wrapped up in our own full or part-time worlds, 1L students feel isolated from the public forum; but this is a public College. Focussed on getting copies, 1L students are blind to their fellows; but these are the pals who will see us graduate. Concentrating on canons of law, 1L students are deaf to common communication; but the social contract requires it. As the first term continues, 1Ls are at risk of flunking out of life altogether.

The SBA can help prevent this. Private lives and private things should be left at home (Ex pro privato commodo ad pro bono publico.). 11s know this rule. Subconsciously, and when we have lost all else, we realize that we're all in this together. We leave our Kinko cards in the copy machines. We leave our books on tables. We forget that we're in the lethal world of law school. In the absence of ethics to the contrary, those of us with presence of mind should use our classmates' They will appreciate this act of sibling love. They will come looking for us; and we will make a new friend. It's hard to get to know fellow law students; but we can make sure that they know us.



As a new kid in the GSU SBA flock, I respectfully request that SBA leaders help clean up our act. Make the message on ethics clear. Take pride in your Law School; contribute to the overall image of the College; and help make the Library a better place to learn. Pick up books especially your classmates' books.
